## Conference Privacy Statement

### Summary

Your information will only be used by University of Dundee and the Scottish Society for Art History for these purposes.

The conference will take place in-person and there will be no live online streaming of it, but the presentations will be recorded and the recording made available by the Scottish Society for Art History to speakers and delegates free of charge, and to others for a small charge.

### The Detail

The personal information you provide us will be used by the conference organisers to help organise and evaluate the Art & Science: Connections & Interactions 2023.

Details will be stored in accordance with current data protection legislation for 12 months after the event. The information you provide us on registration will not be shared with third parties except in the following necessary ways:

1. Speaker's names, organisational affiliation, research interests and talk details will be published in the conference programme in print and online.
2. Delegates' names and email addresses will be held by the University of Dundee and the Scottish Society for Art History and may be shared with Dundee & Angus Convention Bureau to keep you informed about the planning of the conference. This information will also be shared with our secure, third-party event registration system Eventbrite, in order to fulfil your registration.
3. Names, meal choices and dietary requirements will be given to any venue or catering organisations used for the conference.
4. Names and appropriate accessibility requirements will be disclosed to conference and social venues any other service providers where assistance may need to be arranged.

5. Dundee & Angus Convention Bureau will administer a post-event evaluation survey on behalf of the conference organisers. No identifiable information will be required to complete the survey.
6. Name and email address will be held for the purpose of informing you of future conferences and events which may be of interest to you.
7. By law, all delegate information may be shared with law enforcement agencies bearing a warrant for the detection and prevention of crime.
